**Large German Chemical Company Uses Porter Logistics for consolidated Savannah 3PL Services: Import, Export, Distribution, and Manufacturing Plant Support**

### The Challenge

One of the largest chemical companies in Germany had grown its US 3PL warehousing network beyond what was practical for them to manage. They needed to consolidate their Southeast warehouse operations in Wilmington, Charleston, and Atlanta into a Savannah 3PL warehouse that they could trust. They possessed 100's of SKUs across multiple hazard classes (including NFPA class 1 and class 2 flammables) and their customers were not getting timely and accurate orders. They were at risk of losing customers and needed a dependable Savannah 3PL partner to right the ship. In addition, they needed Porter to execute liquid transloading and repackaging.

### How we Helped

Porter Logistics embarked on a multi-month pursuit process, touring 10+ buildings in and around the Savannah market that met the client needs. Porter was able to negotiate \$1M in tenant improvement expenses to build out a flame room capable of compliantly storing liquid flammables with low flashpoints. Porter was able to meet the diverse 3PL warehouse needs in Savannah through a combination of 1) flame room for flammables and combustibles, 2) heated and cooled rooms for temperature sensitive product, and 3) the processes necessary to ensure the client stayed compliant with regulatory rules and internal SLA's. Porter also exports Drums, IBC's, Bags, and other form factors via containers to various customers across the world.
