CASE IN POINT

Resins and Monomers Formulator Consolidates Multiple Ports into Porter Logistics' Savannah Location for Distribution and Repackaging

The Challenge

A resins and monomers manufacturer had a disparate set of chemical warehouses all across the eastern seaboard and Gulf Coast of the United States. They needed to 1) consolidate their chemical 3PL network from many into a single provider, 2) find a provider that could compliantly handle flammable monomers (NFPA class 1 and 2), and 3) provide high volume, extensive repackaging of various resins from supersacks and non-branded 25KG bags to client-branded 25 KG bags. Porter would need to handle high volumes of imports from APAC, EMEA, and the Americas and distribute domestically within the United States. Furthermore, the client needed an analysis of which Port would be optimal for a combination of drayage costs and over the road transportation to their customer base

How we Helped

Porter Logistics dove right into the requirements. The Porter team reviewed volume data for resins and monomers, MSDS requirements - gaining a clear and complete understanding of Hazard classes, flash points, and unique storage requirements. Porter was able to meet the diverse HAZMAT warehouse needs in Savannah through a combination of 1) flame room for flammables and combustibles, 2) heated and cooled rooms for temperature sensitive product, and 3) the processes necessary to ensure the client stayed compliant with regulatory rules and internal SLA's. Porter also engineered and procured repackaging equipment capable of processing over 3000 25KG bags per day.

Results

The client selected Porter as its Hazmat warehouse provider in Savannah, consolidating its presence in Baltimore, Charleston, and Mobile ports in the Savannah market. This move allowed the client to achieve cost savings through its supply chain and provide a better customer experience to its US clients
